F.SRO/NCTE/B.Ed./2006-2007/3314 dt. 25.05.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

- 2. **AND WHEREAS,** on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 16.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 30.05.2015 for conducting **B.Ed. programme** of two years duration with an annual intake of 100 students (Two units) from the academic session 2015-2016.
- 3. AND WHEREAS, the inspection was conduct on 18.11.2016 to 19.11.2016 and VT report received on 21.11.2016. The SRC in its 324th meeting held on 07th 08th December, 2016 has considered the matter and decided to issue a letter. Accordingly, as per the decision of SRC a letter was issued to the institution on 16.12.2016.
- 4. AND WHEREAS, the SRC in its 381st Meeting held on 31st October & 01st November, 2019 decided to issue SCN in all such matters where the institution has not submitted the requisite documents/VT report accompanied with the requisite documents. Accordingly, as per the decision of SRC, a First Show Cause Notice was issued to the institution on 08.11.2019. The institution did not submit any reply to the First Show Cause Notice.
- **5. AND WHEREAS**, the SRC in its 427th meeting held on 20th July, 2023 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 16.08.2023. The institution has submitted its reply received on 18.08.2023.
- **6. AND WHEREAS,** the SRC in its 428th Meeting held on 25th August, 2023 has considered the matter and decided as under:-

"The original file of the Institution alongwith other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Sri Ranga B.Ed. College, Survey No. 94/7, Khata No. 186 MR No. 120, Near Ring Road, Hemavathi Nagar Last Stage, Chikkakondagula, Hassan District-573201, Karnataka for B.Ed. programme for 2 basic units of 50 students each."

The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done. 11.

The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.

- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
